### **EVENT DETAILS**

**Application deadline is August 15<sup>th</sup> 2025.**

When participating in this event a canopy is a must. There is no shade or protection from the elements. Please come prepared. Bring something to cover your items when you leave your booth on Friday pm. You may leave your booth setup as security is provided.

Vendor setup is on Friday September 12<sup>th</sup> from 9am to 4pm. Please arrive early to unload for setup and remove your vehicle to an outside parking area. No vehicles will be allowed to stay as part of your vending area unless approved by the vendor coordinator.

Vendors should be set up and ready to sell by 4pm Friday and will be required to stay until 8pm. The hours for Saturday are from 10am to 4pm. You will be required to stay until 4pm on Saturday to get your deposit returned. Please do not start tearing down your booth until 4pm on Saturday, no early teardowns. Dinosaur Stone Age Stampede has the right to cash your deposit check for rules broken.

For pedestrian safety, vehicles are not allowed to park inside the event after 3pm on Friday, please have all vehicles removed on or before this time.

Your vendor location will be assigned to you and will be directed by the vendor coordinator to your spot upon arrival.

Electrical is not available at this venue, but if needed we will do our best to accommodate your needs. This placement cannot be guaranteed. Food trucks vendors must have a generator to operate.

Vendors are responsible for Moffat County and State of Colorado taxes. Please provide a copy of your State of Colorado Special Event License with this application.
